Remedial Works “Cleanup of Port Authority Office Yard” Grand Turk Ref. No 1101-24

Summary

The Ports Authority of the Turks and Caicos is a government statutory body which is responsible for the supervision, safety and management of sea ports throughout the Turks and Caicos, which facilitates efficient shipping services.

REQUEST FOR SERVICES

The Ports Authority of the Turks & Caicos Islands is requesting quotations (RFQ) from service providers (firms or individual) with relevant business-license and experience to clean-up and remove all vegetation (Trees, scrubs, bushes) and other debris from the Ports Fence Perimeter at South Dock Port Facility Grand Turk.

SCOPE OF SERVICES

Based on the ‘owner requirement brief’ prepared by the Ports Authority the specific service should consists of the following:

1. Removal of all vegetation and debris from the fence perimeter
2. Transportation of vegetation / debris to the public dump



- Lot 1 - Main Road along PWD Mechanic Shop to Main Pier**
(1000' Ft Long and at a minimum of 10' Ft) of Fence Perimeter
- Lot 2 - Main Gate along main road to PWD Mechanic Shop**
(650 Ft., minimum 10 Ft of Fence)
- Lot 3 - Main Gate along back of Office to RoRo Ramp**
(725 Ft minimum 10 Ft of Fence)
- Lot 4 - RoRo Ramp to Main Pier**
(950 Ft, minimum 10 Ft of Fence)

Vegetation should be cleared from both the inside and the outside of the Perimeter Fence.

At the end of the engagement the Port Authority Security team will have an unrestricted view path of the relevant sections of the Fence Perimeter of the Port Facility.

RESPONDING TO THE RFQ

The required services are needed immediately

It is advised that interested service providers should make arrangements to visit South Dock, Grand Turk to inspect the project area to get a better understanding of the project.
